Dear Stakeholders,

This letter serves as notification that the Governing Body of St Monica's Catholic Primary School has commenced the statutory public consultation process regarding its Admission Arrangements for the 2027/2028 academic year.

As the admissions authority for St Monica's Catholic Primary School, the Governing Body is required to consult on its arrangements at least once every seven years, and whenever changes are proposed.

Following a thorough review of our current policy, we have determined that the current arrangements are working effectively and remain compliant with the School Admissions Code.

**Therefore, please note that the Governing Body has proposed NO changes to the current Admission Arrangements for the 2027/2028 academic year.** The current criteria, catchment area (if applicable), and oversubscription priorities will all remain exactly as they are now.
